



## Minutes of the first CALL Assembly on 30 April 2010

### 1. CALL Objectives

The Assembly receives the project proposal (attached). It decides to start working with the suggested working structures. The next assembly will have to decide whether the CALL Network will need more precise working structures.

## The Assembly defines 4 key tasks for the network:

- 1. Campaigning on economic and employment issues
- 2. Networking on economic and employment issues
- 3. Exchange of expertise among members
- 4. Empowering people on economic and employment issues

#### 2. CALL Working Areas

The Assembly initiates 5 working areas:

# 2.1 To launch a citizens' initiative on the work-life balance: "A time to work, a time to live"

The campaign for a citizen's initiative should focus on issues like Sunday protection, reconciliation between work and family life and working times. Proposal for the name of the campaign: "A time to work, a time to live". Dieter Heidtmann will introduce the proposal to the coalition which organised the Free Sunday Conference in the European Parliament.

#### 2.2 Working Group on Precarious Work

The Assembly initiates a working group on precarious work. The working group shall focus on common European standards for decent work, labour migration, "living wages" and related issues. A first project could be to collect information from different countries in order to prepare documentation. The first meeting of the working group could be linked with the ECG Assembly in Vilnius (20-24 October 2010).

#### 2.3 Working Group on Religion in the Public Sphere

The working group shall focus on the different church-state relations and how they have an impact on the presence of the church in society. A first project could be a brochure

with "best practice examples" of the presence of the churches in "new places" where people meet, such as shopping malls.
