1. Church and Society questions on human rights

NV: in Belarus the repressive legislation still exists, but direct repressions against individuals and groups are not very regular, there are very few cases in the domain of freedom of religion or belief. Pastor Alexander Khomtchenko from Donjeck region was witnessing in Brussels in presence of the MEP's about tortures experienced by him from armed groups at the Donjetsk region on religious basis. Hearings were organised by Polish MEP Małgorzata Gosiewska.

Fr. Aimilianos – in Greece a law was adopted in order to be up to date regarding on human rights. This law mostly has been used to suppress the voice of the church, like denial of the ponitici genocide. The government and the church, especially on migration are trying to present situation in such a way that it is not real. Everybody is willing to help the migrants. If the church speaks out against the Greek government it does not reflect positively on the church. People are scared in Brussels due to the attacks. Closing the borders is not a solution that is humanitarian. Turkey – Christian refugees are persecuted in Turkish camps, they find different ways to.. The Ecumenical patriarch will hold the meeting with Pope and Greek Orthodox Archbishop on 16 April in Lesbos. There are many Christians who are still the minority. People have been harassed as refugees. The majority in the camps create tensions.

Patrick – 2-3 issues in Germany: there have been legal changes concerning the right to asylum, including the question which non-EU-countries can be regarded as safe.. It is being discussed, how far the Turkish deal jeopardizes our own values in terms of the human rights regime in Turkey, freedom of press and media and religion. Also, Turkey has been complaining about satirical covering of their president, so that on the one hand a public debate has begun on the state of freedom of opinion in Turkey and in Germany, on the other on cultural sensitivity and respect. These debates have also helped the rise of a new populist (right wing) party in Germany, AfD, which is now present in diverse local and federal-state legislative chambers. The rise of nationalist movements in Germany and abroad is therefore also debated in the context of the migration challenge.

Geesje –

Geesje – government is against religion, normally there will be new laws and no in "the grace of God" will be removed from Dutch laws, government is trying to forbid Salafism, there is a voice in society that there is freedom of religion or belief guaranteed by the constitution.. there are violations against Christian refugees, should there be separate shelters for Christian refugees.. In the Netherlands if refugees use violence against others, they do not receive benefits.. ACT is active in Samos, Chios and Kos, and the Evangelical church in Greece at Idomeni , there is not enough food, or hygiene materials.. the tensions made by Europe also mean that these violations are going on and on...

Pamela: Archbishop of Lutheran, Orthodox, Catholic and Muslim leaders published statements in the newspaper, where Finland was portrayed as a country where family unification is made ever more difficult. It will increase inequality. The government wants to put a limit for what people have to earn per month if they want to have family unification. Through these laws, they want that make Finland less attractive for migrants. The leaders also criticised Europe for abandoning its own ideals. Churches and other religious organisations are working together for migrants.

Göran: Sweden, everybody needs a passport to enter Sweden, what is happening who can enter Sweden, harassment of Christians in the champs, they hear about Kurdish and Turkish groups, there are tensions growing, increased by the different languages within these groups? More asylum seekers are converting to Christianity, last week there were 15 baptised, people want to join the church, they want to change their beliefs..

New law in Switzerland – a Muslim is excused if he doesn't shake the hand with women - where is this debate going?

Seminar – where are the borders on freedom of religion or belief?

2. Evaluation of the EEAS guidelines

So far there were 2 responses and one is in the pipe line. EKi will send a reminder to the CEC member churches on the EEAS guidelines with a deadline no later than May 15.

3. Programme and the invitation – Summer School

EKi informed TRG on HR about the current draft programme, for the Summer School on Human Rights which was developed with Nikos Maghioros from the Theological school of Thessaloniki. The programme was fine-tuned and the majority of the members of the TRG will attend the SSHR. Several changes were made to the programme. The moderatos of the sessions need to leave 20 minutes for the discussions. There should be flexibility for the dinner arrangements as maybe some participants would like to go to down-town.

4. Seminar on Freedom of Religion or Belief in the EP/ autumn 2016

There are 2 dates 27 September and 15 November 2016. The Seminar will be organised by KAS, EPP group and CEC. It will tackle freedom of religion or belief inside the EU and outside the EU.

TRG took the decision to take the part in the universality of human rights in a separate book which will discuss only this concept from different viewpoints. The current programme was

discussed and the frames for the articles were developed by EKI and Patrick Schnabel after the meeting and cases, like Turkey, Germany and UK were added as they belong to different legal systems. It doesn't make sense to have 2 articles of 6000 words, but one article which should take FoRB inside and outside of Europe. Instead of developing the chapter on security and human rights it was suggested by Patrick that this is added under Number 3.
