# Conference of European Churches Together in Hope and Witness Meeting of ecumenical officers and secretaries for theology 24-26 September 2019 (dates tbc) Kaunisniemi, Finland

#### Aim

The meeting will bring together the ecumenical officers of the Member Churches of CEC and the secretaries of theology of the World Christian Communions for a two-day Consultation meeting, which will be convened annually. This meeting will enable CEC to restore regular exchange with its Member Churches and establish new networks and ways of organising its theological work.

#### Objectives

- 1. To listen to priorities and key questions in the areas of ecclesiology and mission. Each participant will be asked to prepare and share in advance a two-page paper on the current burning questions of their Church/Communion. Thematic sessions will be organised and facilitators of the sessions will be identified based on the papers received. This part of the meeting will set the ground for re-establishing theological exchange among CEC Member Churches and will be a concrete step in the process of creating 'an inventory of the theological dialogue between and among Member Churches and identify priorities and key questions of concern' (Strategy Plan column 2, point 3). It will enable CEC to pursue its theological work based on the current needs of the Member Churches. The meeting will take stock of agreements and developments within and between Churches and reflect on how CEC could promote their reception regionally and locally.
- 2. To initiate the Programme on Ecclesiology & Mission. The second part of the programme will focus on enhancing ecumenical cooperation and fellowship with 'migrant' and 'minority ethnic' churches. Participants will be asked to reflect on visions and models of unity, sharing of ministries, and working together in mission. This part of the meeting will help CEC identify the situation on the ground with regard to the realities of 'migrant' churches. It will set the stage to 'discuss ecclesiologies of churches with historical longevity in Europe in dialogue with ecclesiologies of 'migrant' churches, and 'reflect on the impact of the changing religious landscape on the self-understanding of churches' (Strategy Plan column 3, points 3 and 4).
